Arizona Public School Tax Credit Frequently Asked Questions

Q: What is it?

A: The Arizona Public School Tax Credit is a unique program that gives Arizona taxpayers the opportunity to contribute to the extracurricular programs at the public school of their choice and receive a dollar for dollar credit on their state taxes.

Q: How much can I give?

A: Married couples filing jointly can contribute \$400. Individual filers can contribute \$200.

Q: How does it work?

1. Make your tax credit contribution to PCA by 12/31/2020.
2. PCA sends you a receipt for your donation. Hold on to it.
3. When paying taxes in the Spring, you can deduct the full amount of your donation.
4. The resulting figure is what you actually owe Arizona for 2020.

Q: What if I owe the state a remaining balance?

A: For example: If you have a remaining state tax liability of \$1,800, since you donated a \$400 tax credit in 2020, you immediately reduce that figure to \$1,400. That's the final amount of state tax you owe.

Q: What if the state owes me?

A: For example: If you are due a refund from the state of \$200, since you donated a \$400 tax credit in 2020, you immediately increase that figure to \$600. As long as you have a state income tax liability greater than \$400, that's the final amount of your state refund check to you.

Q: So there is no additional cost to me?

A: That's correct. You get your donation back through a dollar for dollar credit off your state tax liability.

Q: Can my family, friends, and co-workers make tax credit contributions to Sun Valley Academy?

A: Yes! As long as they pay taxes to the state of Arizona, they can take full advantage of the Tax Credit. There is no need to have a child at the school.

Q: Can I contribute to this and to private schools?

A: Yes! You can give up to \$200 if single, \$400 if filing jointly to any combination of Public Schools, \$500 if single and \$1000 if filing jointly to any combination of Private Schools, and \$200 if single, \$400 if filing jointly to any combination of organizations that help the working poor (United Way, St. Mary's Food Bank, Assistance League of AZ, etc.)
